We support projects where there is a clear focus on the conservation of iguanas in their native habitat. Beyond that, we will consider funding (in part or whole) projects approaching this goal from many angles: scientific and socioeconomic research, enforcement, restoration, education and outreach, capacity building, etc.

Funding Available

Max 750 € per proposal

Deadlines and Response

Applying can be done throughout the year

Applicants should expect to learn whether their request for funding is awarded within 4 weeks of application submission.

Eligibility

Who Can Apply: Anyone working with herbivorous lizards

Species from the genera: *Iguana*, *Cyclura*, *Amblyrhynchus*, *Conolophus*, *Brachylophus*, *Uromastyx*, *Ctenosaura*, *Cachryx*, *Saara*, *Sauromalus* and *Tiliqua rugosa* and *Corucia zebrata*

What: For example: equipment, research, travel, any conservation activity, outreach and education etc.

Application Instructions

1) Please provide responses to each item in the Dutch Iguana Foundation Grant Application using language/terms suitable for a general audience and keeping within the allotted word count. Add the application as an email attachment.

2) Provide a copy of your CV.

3) If permits are required for any activity being funded through this proposal, then applicant should provide copies of the permit application(s) along with the application.

Note to Applicants

All awardees are expected to provide two submissions to the DIGF online magazine. The first submission will occur at the time of award receipt and the second within 3 months of project completion. *Your answers provided in this application should form the basis of the first submission.*

Grant Reviewing Criteria:

- Anticipated impact on iguana conservation
- Clarity of justification for DIGF funds requested
- Completeness of application responses
- Qualifications to carry out proposed activities (based on applicant's CV)
